In this case nobody wanted to attend to the matter because nobody wanted to be responsible for the deceased person to be disposed. A pauper burial was needed as a case of emergency. de s v iid ditte itoe)	The ODM went out on tender for a wide area radio network consisting of three repeaters interlinked using microwave data. One of these sites is on Groenlandberg near Grabouw, a solar powered site. In the tender provision was made for solar systems, however it could not have been foreseen that Cape Nature will not allow further expansion on the mountain and that the ODM must make use or be accommodated in the existing structures already in use by the District. Upon preparing for installation in that structure it was found that space is a problem and that there will not be enough additional power to power the data links. The alternative is to make use of an existing supplier already on the ODM's system and on site to data-connect the repeaters. Using an independent data linkup will also be the direction taken going forward. This deviation is to house the repeater in Groenlandberg, provide power and connect the repeaters for a three-month period until such time as a tender can be advertised for this service on a longer period.
