IDP/BUDGET/PMS TIME SCHEDULE OF KEY DEADLINES FOR 2025/2026 IDP REVIEW

PURPOSE

To present the IDP/Budget/PMS Time Schedule of Key Deadlines for period 2024/2025 to Council for adoption, in preparation for the 2025/2026 IDP Review and or Amendment, Budget and SDBIP.

BACKGROUND

Section 21(1)(b) of the Local Government: Municipal Finance Management Act (MFMA), 2003 (Act 56 of 2003) states that:

The mayor of a municipality must at least 10 months before the start of the budget year, table in the municipal council a time schedule outlining key deadlines for-

- (i) the preparation, tabling and approval of the annual budget;
- (ii) the annual review of the integrated development plan in terms of section 34 of the Municipal Systems Act.

PROGRESS

The Time Schedule is guided and informed by the five-year District IDP Framework and Process Plan, adopted by Council on 28 March 2022. Subsequent to the adoption of the 5-year Integrated Development Plan (IDP) on 30 May 2022, the Municipality is faced with various changes in circumstances and is therefore legislatively compelled to review and potentially amend the adopted IDP. Such process is guided by section 34 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), which states:

A municipal council-

- (a) must review its integrated development plan-
 - (i) annually in accordance with an assessment of its performance measurements in terms of section 4 i; and
 - (ii) to the extent that changing circumstances so demand; and
- (b) may amend its integrated development plan in accordance with a prescribed process.

In accordance with the Municipal Finance Management Act, and in consultation with the Chief Financial Officer, the Performance Management Officer, Local municipalities in the Overberg and Department Local Government, an IDP/Budget/PMS Time Schedule of Key Deadlines for

2024/2025 was developed in preparation for the 2025/2026 IDP Review and possible Amendment, Budget and SDBIP.

The 2025/2026 IDP Review would serve as Council's Third Review of the 5-Year IDP.

It is confirmed that the IDP/Budget/PMS Time Schedule of Key Deadlines for 2024/2025 was workshopped with IDP Managers across the Overberg in order to ensure horizontal and vertical alignment of various activities on a Provincial, District and Local level.
