



## ***ODM Council Concludes 2025 with Final Meeting and Recognition of Service Excellence***

**The Overberg District Municipality (ODM) Council held its final Council meeting for the year today, 8 December 2025, at the ODM Council Chamber.**

The annual closing meeting provided the opportunity not only to conclude the year's official business but also to celebrate the achievements and the contributions of Councillors and officials throughout 2025.

During the session, long-serving ODM officials who have dedicated 20 years or more to the institution were recognised with service certificates.

The Council also celebrated officials who attained academic qualifications during the year, by acknowledging their commitment to continuous professional development and strengthened municipal service delivery.

### **Appreciation for Fire Services**

A moment of appreciation was extended to the ODM Fire Services for their excellent efforts in combating several recent fires across the region. The Council expressed gratitude for their dedication, resilience, and swift response in protecting lives, property and natural resources.



Fire Services was a central focus of the agenda, with Chief Fire Officer Reinard Geldenhuys presenting the municipality's Fire Season Readiness Plan.

His presentation provided a detailed seasonal outlook based on key risk factors, including weather conditions, human-caused ignitions, and the impact of declining annual rainfall.

He highlighted how increasingly dry vegetation continues to elevate wildfire risk across the Overberg, Cape Winelands and Garden Route districts.

### **Council Recess & Closure of Offices**

The ODM Council will be on recess from 8 December 2025 to 16 January 2026.

The ODM Administrative Offices will close at 12:00 on 24 December 2025 and will re-open on 5 January 2026. The ODM Roads Department will close at 11:00 on 19 December 2025 and will re-open on 19 January 2026.

ODM Emergency Services along with identified Municipal Health Services and Resorts personnel will remain on duty during this period.

## WATER SECURITY IN FOCUS AS PROVINCE ENGAGES MUNICIPALITIES ON SEASONAL PRESSURES

The Department of Local Government (DLG), together with the Department of Water and Sanitation (DWS), attended a special District Coordinating Forum (DCF) meeting in Swellendam to engage local municipalities on the growing water challenges across the province.

With below-average rainfall expected and significantly higher demand anticipated over the holiday season, the provincial focus is clear: ensuring every municipality has the support, resources, and technical guidance needed to keep water systems stable now and into the foreseeable future.

During the engagement, several key concerns were highlighted, including declining dam levels in a number of towns, among them Swellendam, seasonal demand spikes, supply constraints in high-risk areas, and the ongoing need for responsible water use supported by stronger community awareness.

To respond proactively, DLG and DWS outlined a series of interventions already under way. These include conducting

Town-Based Assessments to inform targeted water-resilience planning, prioritising high-risk municipalities based on updated risk profiles, and coordinating the deployment of water tanks, trucks, and technical expertise where needed. Municipalities are also being supported in implementing water restrictions and reducing system losses through leak-management programmes.

Strengthened communication efforts form another key element of the response, ensuring that residents and holiday visitors have access to accurate, timely information about local water conditions and requirements.

This collaborative provincial approach ensures that municipalities, particularly those facing immediate pressure, receive urgent attention and the necessary interventions to safeguard water security for households, businesses, and the seasonal influx of visitors.

Working together, DLG, DWS and municipalities remain committed to building resilient, water-secure towns throughout the Western Cape.

## ODM STRENGTHENS COMMUNITY AWARENESS THROUGH SUCCESSFUL IDP WORKSHOP

21 November 2025 - The ODM's Integrated Development Planning & Communications department held an IDP Awareness Workshop to strengthen understanding of key municipal processes and encourage active participation in local development.

The programme covered several important topics, including climate change resilience, where Environmental Management Services highlighted increasing climate risks such as fires, drought, and flooding, and the need for coordinated adaptation efforts.

Municipal Health Services presented on food labelling and the monitoring of expired goods, emphasising how proper compliance helps prevent health risks within communities. Social Development also addressed mental health awareness, focusing on early intervention, access to support services, and the importance of community partnerships.

The workshop included an overview of ODM's communication approach, reaffirming the municipality's commitment to transparent,



accessible, and two-way communication with its stakeholders. The IDP & Communications team further presented on Integrated Development Planning, the role of public participation, and an overview of the Overberg District's profile.

The workshop, which was facilitated by the Manager: IDP & Communications, Mr Franco Ruiters, reinforced ODM's commitment to collaboration, informed communities, and inclusive development planning across the district.

**ACTIONS CONSTITUTING CORRUPTION, FRAUD, THEFT AND MALADMINISTRATION**

**Offences constituting corruption, fraud, theft and maladministration collectively refer to, but are not limited to:**

- any dishonest, fraudulent or corrupt act;
- theft of funds, supplies, or other assets;
- maladministration or financial misconduct in handling or reporting of money, financial transactions or other assets;
- making a profit from insider knowledge;
- disclosing confidential or proprietary information to outside parties;
- irregularly accepting, requesting, offering or giving anything of material value to or from contractors, suppliers or other persons providing services/goods to the Municipality;
- irregular destruction, removal or abuse of records, furniture and equipment;
- use of the municipality's assets for personal gain;
- any similar or related irregularity; and
- deliberately omitting or refusing to report or act upon reports of any such irregular or dishonest conduct.

## MINISTER SIMMERS OFFICIALLY OPENS UPGRADED BOONTJIESKRAAL ROAD



A R43.5 million Western Cape Department of Infrastructure (DOI) project to upgrade and conduct emergency repairs on Main Road (MR) 276 (Boontjieskraal Road) near Bot River was recently completed.

MR276 is a 6.7km road that runs from the N2 between Bot River and Caledon on one end, and the R43 between the N2 and Villiersdorp on the other end.

During the ceremonial opening of the road, Western Cape Minister of Infrastructure, Tertuis Simmers was pleased to announce that the project created 113 short-term work opportunities and 6 885 person-days of work.

"R11.8 million was spent on procuring goods and services from targeted enterprises, and three local enterprises and four emerging contractors benefited from the project," the Minister stated.

# WORLD ENVIRONMENTAL HEALTH DAY

## ENSURING HEALTHY COMMUNITIES

On 13 November 2025, the Municipal Health Services team marked World Environmental Health Day with impactful community outreach activities across Caledon.

In Riemvasmaak, officials led an educational session on proper handwashing practices and the importance of clean air for everyday health. Learners and community members were engaged through practical demonstrations and interactive discussions.

Meanwhile, another team conducted an oil blitz at 12 food premises in Caledon, focusing on safe oil usage, correct disposal methods, and overall food safety compliance. These inspections help ensure healthier environments and safer food for our communities.

By promoting awareness and strengthening good environmental health practices, the ODM continues to support a healthier, informed, and resilient Overberg region.



## PROMOTING INTEGRITY AND ACCOUNTABILITY ACROSS THE OVERBERG

A workshop focusing on the Code of Ethical Leadership in Local Government was held on 17 October 2025, bringing together councillors and municipal officials from the Overberg District Municipality, Cape Agulhas, Overstrand, and Theewaterskloof local municipalities.

The session, facilitated by the Western Cape Government in collaboration with the South African Local Government Association (SALGA), provided an important platform to engage on ethical principles and leadership responsibilities within the local government sector.

Through insightful presentations and interactive discussions, participants explored practical ways to strengthen ethical conduct, promote transparency, and reinforce accountability in municipal governance.



The workshop also highlighted the importance of building a culture of trust and integrity to enhance service delivery and uphold the values of good governance.

The initiative forms part of ongoing efforts by the Western Cape Government and SALGA to support municipalities in developing ethical leadership practices that ensure effective and responsible local administration across the province.



# ODM HOSTS CLIMATE CHANGE WORKSHOP TO STRENGTHEN LOCAL CLIMATE RESILIENCE

The Overberg District Municipality (ODM) hosted a two-day Climate Change Workshop on 29 and 30 October 2025 at the ODM Council Chamber in Bredasdorp. The engagement brought together municipal officials, environmental specialists, and sector partners to assess the district's climate change needs and develop a practical implementation plan to guide local response efforts.

## Overberg Climate Change Needs and Response Assessment

The workshop commenced with an opening and welcome by Mr. Eben Phillips, ODM Director of Community Services, followed by a presentation by Ms. Shandré Laven, Control Environmental Officer from the Department of Forestry, Fisheries and the Environment (DFFE), who highlighted ODM's key role in climate change response.

SALGA shared a case study from the West Coast District Municipality under the Municipal Support Programme for the Climate Change Act, providing insights into local government adaptation processes. The University of Cape Town's African Centre for Cities discussed lessons from the recent flood responses in Cape Agulhas, while SALGA explored the role of human resources in advancing climate resilience and a just transition.

The afternoon sessions included input from the Western Cape Government's Department of Environmental Affairs and Development Planning, who unpacked the region's climate risks and vulnerabilities, and the Department of Energy, who presented on the Energy Security Programme under the Department of the Premier.

The DFFE introduced the Theory of Change Framework to guide the development of an implementation plan, followed by the Department of Cultural Affairs and Sport, who discussed the importance of effectively communicating climate change.

## Development of the Implementation Plan

The second day focused on consolidating discussions into actionable steps. The sessions encouraged departmental feedback on their respective roles and commitments to climate adaptation and mitigation. Officials worked together on institutional accountability measures to ensure long-term implementation of climate initiatives.

The workshop concluded with closing remarks by Mr. Richard Bosman, ODM's Municipal Manager, who thanked participants for their active engagement and reaffirmed the municipality's commitment to building a resilient and sustainable Overberg.

# WESTERN CAPE INVESTMENT SUMMIT 2025

WHAT HAPPENED AND WHAT THE OVERBERG DISTRICT MUNICIPALITY TOOK TO CAPE TOWN



The Western Cape Investment Summit (WCIS 2025), held at the CTICC from 5–7 November 2025, brought provincial government, district and local municipalities, investors and the private sector together to showcase pre-vetted “deal” opportunities across eight priority sectors and to accelerate private investment into the Western Cape economy. The Summit was hosted by the Western Cape Government’s Department of Economic Development & Tourism and positioned the province as a global investment destination of choice.

The WCIS 2025 was framed as a three-day, province-wide push to connect local, national and international capital with a pipeline of projects aimed at infrastructure, water security, tourism and other growth sectors - with a public target to significantly grow private investment in the region. Organisers released a Deal Book of pre-vetted projects to guide investor discussions and matchmaking at the Summit.

Provincial leadership, including Premier Alan Winde, presented the opening address, stressing investment as the engine of growth and the importance of coordinated public-private action to scale jobs and economic opportunity.

## Overberg District Municipality at the Summit

The Overberg District Municipality participated in the Summit to present regional opportunities and to engage directly with potential investors and other municipalities. ODM and related Overberg tourism channels posted from the event, highlighting the District’s presence on the exhibition floor and noting a number of project themes they promoted, notably:

### • Water Security / Overberg Dam Opportunity

- The Summit’s Deal Book included an Overberg Dam Water Security project listed as a potential regional investment. Overberg representatives used the Summit to place this project before investors looking at infrastructure and water resilience deals.

• **Tourism & Wine-route Development** - The ODM promoted wine-tourism development and other value-chain opportunities in the visitor economy.

### • Broader service-sector and innovation

**themes** - The District aimed to position itself for diverse investment types and forward-looking items like spaceports (as a conversation topic shared on social channels).

## What this could mean for Overberg

i) **Follow up on Deal Book leads** - the Overberg Dam listing gives the District a concrete pipeline item to push toward feasibility, funding and investor diligence. Converting interest into proposals and public-private partnership (PPP) terms should be a priority.

ii) **Package tourism investments as investable projects** - investors respond to clearly scoped packages (land, regulatory pathway, projected returns). Overberg’s tourism/wine value chain items would benefit from investment-ready business cases.

iii) **Coordinate provincial & neighbouring district contacts** - networks formed at the WCIS create opportunities for co-funded or regional deals.



# MUNICIPAL HEALTH & AIR QUALITY SERVICES APPRECIATION CEREMONY

The ODM's Municipal Health & Air Quality Services department proudly celebrated the dedication and extraordinary service of its officials.

From responding to major health-related challenges, including Listeriosis, COVID-19, regional flooding impacts, and the recent food poisoning emergency, the EHPs and support staff have consistently gone above and beyond to safeguard the wellbeing of our communities and visitors. Their long hours, rapid response, and unwavering professionalism remain a cornerstone of preventative health in the Overberg.

# FESTIVE SEASON FOOD SAFETY GUIDE

The festive season is a time of celebration, travel, and shared meals with family and friends.

Unfortunately, it is also a period when foodborne illnesses increase, largely due to factors like high temperatures, large gatherings, and improper food handling practices.

Food poisoning can affect anyone and may quickly turn festive celebrations into a health emergency.

By understanding the risks and following basic food safety guidelines, residents can help protect themselves and their loved ones throughout the holiday period.

## Safe Food Handling Tips

- Keep it hot: Cook food thoroughly and ensure that hot dishes are kept at temperatures above 60°C.
- Keep it cold: Refrigerate leftovers within two hours to prevent bacterial growth.

- Avoid cross-contamination: Always separate raw meat from cooked foods.
- Hygiene first: Wash hands regularly, clean preparation surfaces, and use clean utensils.
- Do not leave food out: Bacteria multiply rapidly in warm weather.
- Travel smart: When travelling, store food in cooler boxes/bags to maintain safe temperatures.

## Recognising Food Poisoning

Common symptoms of food poisoning include vomiting, diarrhoea, stomach cramps, and fever.

Medical attention should be sought immediately if symptoms worsen or if they affect vulnerable groups such as children, the elderly, or pregnant women.

## PROTECT YOURSELF AGAINST BANK FRAUD

Never share your PIN, passwords or OTP and be cautious of unsolicited requests for personal information via email, phone, or text. Always monitor your accounts regularly for suspicious activity, use strong, unique passwords for your online accounts, and verify payment details before sending money. Be extra vigilant at ATMs by shielding the keypad when entering your PIN and never accepting help from strangers.

### **Vishing:**

Fraudsters call pretending to be from your bank or a trusted institution to steal sensitive info, money, or install malicious apps.

### **Red flags to watch for:**

Caller asks for usernames, passwords, OTPs, or banking details  
Claims of account issues or urgent action needed  
Received a suspicious call requesting you to process transactions to secure your funds  
Threats of account closure or legal action  
OTP received without transacting

### **Protect yourself:**

Be cautious of unsolicited calls asking for confidential info  
Hang up and call the bank using a trusted number

Only use OTPs on the transactions you have initiated and always check what the OTP refers to.

# ODM REMAINS COMMITTED TO PROTECTING YOUR PRIVACY

In today's interconnected digital landscape, safeguarding personal information is more important than ever.

Ensuring the security and integrity of personal data is a shared responsibility. South Africa's Protection of Personal Information Act (POPIA) is designed to protect individuals' privacy by regulating how personal information is processed. The Act came into full effect on 1 July 2021.

Municipal Manager Mr Richard Bosman serves as the ODM's Information Officer, supported by Deputy Information Officers Mr Eben Phillips, Mrs Vanessa Zeeman, and Chief Financial Officer Mr Shaun Stanley.

The Municipality has also established a POPI Co-ordinating Committee, chaired by Ms Celeste Domingo, Senior Manager: Contract, Legal, ICT, Building Management and Support Services. She is responsible for building capacity within the committee and ensuring compliance with the legislative framework, administered by the Manager: Administration, Mrs Alison Thompson.

Under POPIA, "personal information" refers to data relating to an identifiable, living person - or, where applicable, an identifiable juristic person - including but not limited to:

- ◆ demographic details (such as race, gender, age, and marital status);
- ◆ educational, medical, financial, criminal, or employment history;
- ◆ identifying details (such as ID numbers, contact details, and location information);
- ◆ biometric data;
- ◆ personal opinions, preferences, and confidential correspondence;
- ◆ opinions of others about that person; and
- ◆ a person's name when linked to any of the above information.

The Act requires organisations to inform individuals about how their personal information is collected, used, disclosed, and destroyed. It also compels organisations to uphold strict data protection standards and to report security breaches without delay.

Overberg District Municipality supports and empowers institutions to meet their POPIA obligations, including the prompt reporting of data breaches. Timely reporting ensures regulatory oversight and enables swift corrective action to mitigate risks to sensitive information.

# UNUSUALLY EARLY FIRE ACTIVITY HIGHLIGHTS NEED FOR VIGILANCE

Over the past few weeks, our region has already experienced multiple significant fire incidents, including fires around Bredasdorp, Grabouw, Bot River, Hermanus and Villiersdorp, well before the traditional height of the fire season. Historically, the fire season in the Overstrand area begins on 1 November, with the wider Overberg typically entering full fire-season readiness by early December.

That makes the current spate of fires, including the major Gansbaai blaze, unusually early, and a stark reminder that wildfires don't always "stick to the calendar." The early onset underscores the need for constant vigilance, especially under the increasing influence of changing climatic and environmental conditions, dry vegetation and wind.

Now more than ever, we urge everyone in the community to be alert. Here are a few important pointers for this fire season:

- ✓ Clear and maintain defensible space around homes, barns and outbuildings. Remove dry leaves, dead wood, overgrown vegetation, and keep gutters and air vents cleared.
- ✓ Ensure fire-breaks are in place and access routes are clear enough for fire trucks, especially on properties bordering fynbos or mountainous terrain.
- ✓ Watch the daily fire danger index (FDI) and avoid any open-air fires (burn-offs, debris burning, etc.) on "Red" or high-risk days.
- ✓ Report any sign of smoke or fire immediately, even if it seems small, to local fire control. Early detection and rapid response saves lives, homes, and natural habitat.
- ✓ Keep your firefighting equipment (bakkie-sakkies, hoses, nozzles, tools) serviced, checked and ready.
